As a specialist in international education policy, I combine the academic disciplines of comparative education and political sociology with applied research and practice in global education contexts and issues. Specifically, I am interested in how power and politics affect the educational chances of the most vulnerable children and adults around the world. I have written about educational equity and social justice, gender and education, migration and education and educational governance. Using a critical theoretical approach, I consider the complex roles and often contradictory actions of individual and institutional actors, and, when possible, I seek understanding of how global trends are interpreted and enacted locally and vice-versa through borrowing and transfer of concepts, practices, and policy.
